## **Bart's Bash: Notice of Race**

Andrew Simpson Sailing Foundation (ASSF), in conjunction with Host Clubs worldwide.

#### **NOTICE OF RACE**

### 1. RULES

- **1.1** The regatta will be governed by the Rules as defined in The Racing Rules of Sailing 2013 2016.
- **1.2** Local rules and/or bye-laws of Host Clubs may apply. These will be detailed in the Supplementary Sailing Instructions for each Host Club.
- **1.3** Racing Rules may be changed by the Host Clubs and these amendments detailed in the Supplementary Sailing Instructions.
- **1.4** If there is a conflict between languages the English text will take precedence. If there is any inconsistency between this Notice of Race and the Supplementary Sailing Instructions, this Notice of Race and the ASSF Sailing Instructions will prevail.

#### 2. ADVERTISING

**2.1** Advertising will be allowed in accordance with the Class Rules of the competing classes and those of the relevant national authority (if any).

**2.2** Boats may be required to display advertising chosen and supplied by ASSF.

#### ELIGIBILITY AND ENTRY

- **3.1** Bart's Bash is a global umbrella event founded by ASSF that comprises many hundreds of individual sailing events at locations around the world.
- **3.2** Each individual event is organised by the club which is the organising authority for all activities at their site (Host Club).
- 3.3 Barts Bash is open to any sailing craft defined by a class. ASSF will allocate each sailing class with a Bart Number which will be used for handicapping purposes. The Bart Number list will be published at www.bartsbash.co.uk and classes that do not have a Bart Number should contact ASSF so that one can be generated.
- **3.4** Eligible boats may enter online in advance at the online entry website through www.bartsbash.co.uk.
- **3.5** Where available, boats may also be able to enter at the Host Club at which they choose to race.

**3.6** To comply with the requirements of the Guinness World Record attempt, competitors must sail a minimum distance of one thousand metres around the course, and for a minimum time of fifteen minutes, in order to qualify for results and for world record numbers.

#### 4. FEES

There are no entry fees for this event. Each participant is encouraged to make a donation to ASSF when completing the entry form of £5 or more although this is not a requirement to participate.

## 5. SCHEDULE

5.1 The race start time and finish time must take place between 00:00 GMT and 23:59 GMT on 21st September 2014 and subject to clause 3.6 above, the starting time and length of each race is a matter entirely for the relevant Host Club. This time frame is applicable regardless of which time zone the races are being held.



**5.2** The Schedule of Racing will be published in the Supplementary Sailing Instructions of each Host Club.

#### MEASUREMENT

If applicable, boats may be required to produce a valid measurement certificate at registration. Random measurement checks may be carried out during the event at the discretion of the Race Committee of the relevant Host Club.

#### 7. SAILING INSTRUCTIONS

The Sailing Instructions will be available at www.bartsbash.co.uk. Supplementary Sailing Instructions will be available from the Host Club

#### 8. THE COURSE

The course to be sailed will be shown in the Supplementary Sailing Instructions or described at the briefing at the Host Club.

- **8.2** The course set by each Host Club must meet the following criteria:
- a) The start and finish of the race must be in the same place; ideally this will be a Gate, but separate start and finish lines from the same race committee boat are acceptable (ie, one line either side).

- **b)** To comply with the requirements of the Guinness World Record attempt, the distance sailed by competitors must be a minimum of one thousand metres. This can be accumulated over numerous laps.
- c) To comply with the requirements of the Guinness World Record attempt, the race duration must be a minimum of 15 minutes.
- d) The course has no required minimum number of rounding marks, however a clear course must be available and published by the Host Club (e.g. a course could be laid using race marks, or boats could sail around an island, or between two shore-based gates on a river etc).

#### 9. SCORING

The Race will eventually be scored based on average boat speed handicapped using each class' Bart Number. Results will be published at www.bartsbash.co.uk. Given the variety of conditions by which the event is to be held on a worldwide basis, any handicap results may be inaccurate and no responsibility is accepted in respect thereof.

#### 10. RADIO COMMUNICATION

Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile phones or any similar device.

## 11. TERMS AND CONDITIONS OF PARTICIPATION

#### (a) RISK STATEMENT

Rule 4 of the Racing Rules of Sailing states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone".

Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:

- (a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
- **(b)** They are responsible for the safety of themselves, their crew, their craft and their other property whether afloat or ashore;

- **(c)** They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
- (d) Subject to clause 12.(b), it is their responsibility to ensure that they have adequate insurance in place to cover death, injury, damage or loss (including to third parties caused by their own actions or omissions);
- **(e)** Their craft is in good order, equipped to sail in the event and they are fit to participate;
- (f) The provision of a race management team, patrol boats and other officials and volunteers by the event organiser and Host Clubs does not relieve them of their own responsibilities;
- (g) Each participant is to accept that is their responsibility to follow the Host Club's Supplementary Sailing Instructions including their safety instructions at all times
- **(h)** Participation of children under the age of 16 years is the responsibility of their parents or guardians.
- (i) Each participant acknowledges that whilst a handicapping system will be applied, the differing conditions and venues means that there will be a degree of uncertainty as to whoever may be declared as being the winner.

## 12.(b) INSURANCE

Each craft is required to hold adequate insurance and in particular to hold insurance against third party claims in the sum of at least £2 million; this minimum may be amended as appropriate, in the sailing instructions of the host club.

#### 12.(c) MEMBERSHIP AND LIABILITY

Any Membership requirements of each Host Club will be detailed in the Supplementary Sailing Instructions.

#### 12.(d) LOCAL RULES

Any local rules or regulations will be detailed in the Supplementary Sailing Instructions.

## 12.(e) DATA PROTECTION

- Each participant agrees that the Personal Information relating to that individual can be stored, used by ASSF and its Event partners in connection with the organisation, staging and administration of the Event.
- Each participant agrees that the Personal Information relating to that individual may be anonymised and the anonymised data may be used by ASSF and its Event partners in connection with the compilation of statistical information.

- Each participant agrees that their name, image and contact details can be used by ASSF and its Event partners for the purposes of the promotion and marketing of the Event; adding them to a mailing list to keep them informed about future events and services which ASSF believes you might be of interest, such as leisure activities relating to either similar types of events or activities; promotional and marketing material in respect of similar events, other community based activities organised by ASSF's Event Partners.
- Any participant who does not wish ASSF or its Event partners to use the Marketing Information or Personal Information other than for purposes related to their participation in the Event should e-mail ASSF at tim@bartsbash.co.uk.

## 12.(f) MISCELLANEOUS

- Each participant will follow the Guinness World Records compliance to help set and be part of the world record 'the largest sailing event in 24 hours (multi venue)'.
- To the maximum extent permitted by English Law, ASSF accepts no responsibility for injury, loss and damage sustained by a participant and



reference is made to the Risk Statement and Insurance provisions above. ASSF will have no liability whatsoever in contract, tort (including negligence), breach of statutory duty or otherwise for any indirect, incidental, special, exemplary or consequential loss including, without limitation all loss of profit, opportunity, anticipated profit or revenue, business and/or goodwill).

- In the event that a Host Club cancels their event for any reason, the Bart's Bash race will not be held on another day and no donations or fundraising will be refunded.
- The laws of England and Wales apply and each participant consents to the exclusive jurisdiction of the English Courts.
